Fence/Sidewalk- Nothing new at this time.

**Grand Stand-Purchase Tools-**Jim Kauth informed Angie that there are some specific tools that need to be purchased for the project. 1)Shear plate 3/4 " bolt-Dapping tool 304 for shear plate SP4. 2)Split ring ¾" bolt- Grooving tool 302 for split ring TR4 or Split Ring ½" bolt-Grooving tool 301 for split ring TR2.5. The tools will be purchased by Sid Johnson & Co. and the tools become property of the fairgrounds/fairboard. The tools will be paid for out of the 351 construction account.

#### **New Business:**

Fair Update-Angie reported that the fair sponsor dollars are coming in and currently we have 2950.00 in cash with one new sponsor from Commercial Tire in the amount of \$400. She reported at this time we have 3 business with ¼ page ads and 1 business with 1/8 page ad. The Sale Committee requested that the Tractor/Truck pull be moved to Thursday evening. Angie explained that the bronc riding did not want to move. After some talk the fair board agreed to move the tractor/truck pull. Angie is to call JR and discuss concerns and see if she can reschedule the other events. Angie informed the fair board and members that Logan Kerns wanted to host a breakfast during fair for

the kids but did not want to take away from the 4-h booth or the fair board breakfast. The members suggested to have one in recognition for Gerald Colton and have it on the morning of weigh in. Angie to see if that will work for Logan.
