Panels for goat/sheep Barn- Moving the goats to the sheep/pig barn has created a security problem. Angie spoke with Behlen for pricing or donation of panels. The panels would secure the entire length of the barn on the Leo Adler side, across the width at the edge of the concrete and back up the south side to secure the goats and sheep. Behlen donated the panels and the fair board needs to purchase 6 walk thru gates. Dean made a motion to let Angie purchase those gates at 81.00 each Mark seconded the motion and the motion passed. Mark Bennett advised us that Idaho Power could possibly have some grant money to help out with the purchase. Angie is to contact Mike Ybarguen. Terri Siddoway asked to include 10 more 8ft Powder River panels for the beef barn.
