Correspondence: Fair Funds from the state have been mailed out however we have been requested to return them because they cannot be issued until after the Fair Commissioners meet Nov 17. We do not know the amount of them as yet.

- d) Grants—Ann said idaho power ok'd us for a grant but could not give us an amount.

e) West Entrance—Painting is completed on west entrance, Powder River Electric will be installing one LED over the main entrance so that we can evaluate the amount of light prior to installing others. Ne-Hi is working on an estimate for the signage above the door. OSU will fund \$500 of this sign and the remainder will be covered by the USDA Grant. I did check into having the painting covered by the USDA, however, it cannot due to wording in the application being specified to the inside only. Ann said Baker Fairboard needed to be on sign first.

New Business

- a) OSU Lease Agreement— Cory spoke that he has been speaking to OSU and they are to write up something and get it to Cory. Cory thought we should have something by next meeting. Cory also spoke about fiber optics, OSU to cover installation and then we to pay \$100 month for usage budgeted for next fiscal year. Cost to install fiber opics quoted by OSU to cost \$55,000. Start work next spring.

- c) Christmas dinner-- was scheduled for December 15th at 6:00pm. Ann said Friends of Fair to buy prime Rib. Ann is taking charge of cooking.
