Assumption of Risk: The undersigned hereby acknowledge and agree that they understand the nature of the Fall Vendor Market, location (terrain), and are in good health and physical condition to participate. They are aware there are certain inherent risks and dangers associated with the Fall Vendor Market and its location. They, knowingly and voluntarily, accept, and assume responsibility for, each of these risks and dangers, and all other risks and dangers that could arise out of, or occur during participation in the Fall Vendor Market. They understand that animals in their possession or care who are not service animals will need to be removed as they are not allowed at this event. As well as understand that we cannot provide uniform table sizes and that table assignments are randomized.

Release and Waiver: The undersigned hereby RELEASE, WAIVE, AND COVENANT NOT TO SUE the Baker County Fairgrounds, Conference & Event Center, Baker County Fair Board, OSU, or any of their officers and volunteers, from all claims, suits or actions resulting from any personal injury, accessibility concerns, accident, or illness (including death), and/or property loss, or any action related to the participant's participation in the Fall Vendor Market. Participant shall be solely responsible for notifying the organizer in writing if they require accommodation at least 2 weeks prior to the event. The organizers in good faith shall attempt to implement reasonable accommodations in advance.
